- Bill Webb, CFSI's Executive Director, delivered a report
- Thank you for everyone's support in putting on the dinner

  - Master of Ceremonies Denny Compton
- Good attendance at the event
- New support Anheuser-Busch water program
  - They want to expand the program. CFSI offered its support with this effort
- We've been stressing the educational portion of the event

- 17<sup>th</sup> Annual Harry S. Truman Legacy Symposium and the Truman Fire Forum
- Community Risk Reduction Symposium with Vision 20/20 recognized Meri-K Appy
  - Appy Vision 2020 received a grant to host a symposium with CFSI to prepare the future leaders of community risk reduction
  - Appy Recent smoke alarm summit in Baltimore to identify gaps practices and behavior research

## Legislative Report

- Sean Carroll, CFSI's Director of Government Affairs, delivered a report
- Folders contain our recent legislative memo
  - Snapshot of some of the issues we have been and will be working on
  - Legislative Outlook and list of legislation is posted on our website
- Congressional Fire Services Caucus
  - Began the year with 199 members
  - Co-Chairs have led an aggressive recruitment campaign in conjunction with local, grassroots outreach
  - Currently at 221 members
  - Senator Thomas Carper (DE) is the current chair
- Fiscal Year 2020 Appropriations
  - Working with Congressional allies to increase appropriations for FIRE/SAFER, USFA, the Urban Search & Rescue System, and to fully fund the Firefighter Cancer Registry
- Technical correction so qualified improvement properties (QIP), including fire sprinkler retrofits, are eligible for accelerated depreciation (S. 803/H.R. 1869)
- Will be working with Congressman Bill Pascrell, Jr. (NJ-9) on a high-rise fire sprinkler retrofit bill
- Several initiatives contained in resolutions that will be discussed later today
- Many more initiatives covered in the legislative memo and on our website

## Presentation – Pamela Williams, BuildStrong Coalition

- December 2018 report from the National Institute of Building Sciences (NIBS), the benefit-cost ratios for mitigation strategies studied found:
  - Adopting model codes saves \$11 per \$1 spent
  - Federal mitigation grants save \$6 per \$1 spent
  - Exceeding codes saves \$4 per \$1 spent
  - Mitigating Infrastructure saves \$4 per \$1 spent
- 2018 Congress passed the Disaster Recovery Reform Act (DRRA)
  - \$1-3 billion in the hands of states/locals to invest in mitigation
  - Allows FEMA to fund the implementation and enforcement of codes
  - Clarifies that mitigation efforts in post-wildland fire areas are allowable expenses
- BuildStrong is working with FEMA to draft guidance

- Working with states that have taken proactive measures that allow them to tap into an extra 10% of disaster funds
- BRIC Building Resilient Infrastructure and Communities
  - Build capacity across the country small investments can make a difference
  - FEMA is wholly embracing these concepts and working with the Coalition
- Power/water/infrastructure is where we need to invest
- None of these assistance programs exist in a vacuum
  - Pre-disaster mitigation conversation flows right into the disaster recovery conversation and all these programs are being leveraged with funds from other agencies and departments
    - Finally, connect more dots than ever before
  - The burden still lies with the state and local levels
  - BuildStrong Coalition is trying to highlight best practices
- Other issues discussed include the surface transportation package, potential infrastructure package, appropriations for disaster programs, and the Community Development Block Grant Disaster Recovery Program (CDBG-DR) authorization
- July 22<sup>nd</sup> Forum on Building Resilient Infrastructure and Communities
- Q&A Julius Hallas (NASFM) Is the focus on new construction or retrofit?
  - Williams It absolutely needs to be a combination. There is an opportunity for retrofitting. We need to look at new construction, but we have such a stock of older properties. Need to address human behavior and educate on why we need to invest in codes.

# Presentation – Mike Varney & Chief Richard Carrizzo (FirstNet) and Guerdy Charles (AT&T) –

- Varney Looking at ways to continue to improve the network and meet the needs of public safety
  - Looking to the future to ensure FirstNet is meeting the needs of the public safety community
  - Leveraging LTE technology: Need to increase coverage and capacity, improve situational awareness, and integrate voice communication
    - Need to do all of this in a secure information exchange environment
- Carrizzo This is a 25-year program and we're only 18 months into it. We're still building the system.
  - Takes approximately \$81 million annually to run the general operations of the system
    - FirstNet Authority takes another \$81 million in a contingency in case anything happens
    - First reinvestment check for \$78 million came last year
    - Should receive another \$78 million this October
    - Over the next 25 years, FirstNet Authority will take in a little less than \$30 billion
  - Developing a roadmap to determine where we need to go
  - First Responder Network Authority governs AT&T
- Charles Personal survivor of multiple fires

- Served at World Trade Center for three weeks following the September 11<sup>th</sup> attacks
- The year prior to FirstNet was instituted, AT&T's emergency response team responded to 27 emergencies
  - AT&T participated in more 272 emergencies last year
- FirstNet is the fastest growing telecommunications network in the United States
  - Over 575,000 FirstNet connections with over 7,200 agencies
- The pace of adoption is increasing
- Q&A Justin Daniels (CCFS) Heard statement that FirstNet expected to reach 60% adoption by the end of the year. Is that accurate?
  - Charles That is probably a little low. We are on pace to eclipse that.

    - Increased number of seminars we offered this year

  - Continued our partnership with Columbia Southern University;
    - CSU provides CEUs for the seminars at no additional cost to CFSI or the participants
  - Hosted 18 Seminars over two days
    - The most comprehensive program we've hosted
    - Town Hall meeting was well attended and had some good discussions
- Fundraising Vickie Pritchett
  - Fundraising subcommittee has been working with Steven Tramel to enhance existing fundraising programs
  - What more can our organizations do as members of the National Advisory Committee to financially support CFSI?

    - Offered by the International Code Council, and cosponsored by the International Association of Fire Chiefs, the National Association of State Fire Marshals, and the National Volunteer Fire Council
    - Motion: International Code Council

- Seth Statler recommend an amendment
  - Change language where it reads "Model codes" to "consensus-based codes"
  - Motion second National Fallen Firefighters Foundation
  - Motion to amend unanimously approved
- Unanimously approved
- A resolution expressing concern about growing damage from wildfires and encouraging increased support for coordinated community risk reduction, research, and suppression efforts, including adequate equipment as well as personnel resources
  - Offered by the National Fire Protection Association, and cosponsored by the International Association of Fire Chiefs, and the International Code Council
  - Motion: National Fire Protection Association
  - Second: International Association of Wildland Fire
  - Sean DeCrane recommend an amendment to use "consensus-based" so the resolution is consistent with the previous resolution
  - National Association of State Fire Marshals and International Association of Wildland Fire requested to be listed as co-sponsors
  - Unanimously approved
- A resolution in support of the Helping Emergency Responders Overcome (HERO) Act
  - Offered by the International Association of Fire Fighters, and cosponsored by the National Volunteer Fire Council
  - Motion: International Association of Fire Fighters
  - Second: National Fallen Firefighters Foundation
  - Unanimously approved
- A Resolution in support of legislation extending the September 11th Victim Compensation Fund Act
  - Offered by the International Association of Fire Fighters, and cosponsored by the National Fire Protection Association
  - Motion: International Association of Fire Fighters
  - Second: UL
  - Unanimously Approved
