2:35 PM EST Legislative Report – Michaela Campbell

- On appropriations, we appreciate the support of NAC members to help advocate for several fire service provisions, including support for AFG and SAFER, USFA, fire sprinklers, carbon monoxide poisoning prevention grants, USAR, National Firefighter Registry, and other funding lines.
- AFG and SAFER did receive a 6% cut on the Senate DHS bill and we continue to support the House numbers.

- We are working on the reauthorization of the National Firefighter Registry, which was attached to the National Defense Authorization Act (NDAA) in the Senate. We are advocating to keep the measure included in the final FY24 NDAA.
- We continue to push hard in support of reauthorization of AFG, SAFER, and USFA.
- The Fire Grants and Safety Act (H.R.4090/S.870) must pass before AFG and SAFER sunset on September 30, 2024.

- We launched a WUI virtual handbook in 2023. It can also be downloaded for offline use.
